THE FEDERAL BUDGET COVERS ONLY ABOUT 25% OF THE ANNUAL COST OF MAINTANING THE OFFICIAL TRAIL SYSTEM IN THE TRAIL FUND'S AREA. THROUGH A SPECIAL FUNDING AGREEMENT THE SEDONA RED ROCK TRAIL FUND IS ABLE TO FUND PART OF THE EXPENSE IN THE SEDONA AND VILLAGE OF OAK CREEK AREA. THE FUNDS PROVIDED IN SEPTEMBER 2018 (PRIOR FY) ENABLED THE RED ROCK RANGER DISTRICT TO FIELD AN 8 MEMBER NON-MOTORIZED TRAIL CREW INCLUDING ONE FEMALE. THE CREW CONSTRUCTED ABOUT 5 MILES OF NEW TRAILS AND PERFORMED LIGHT AND HEAVY MAINTENANCE ON OVER 250 MILES OF OFFICIAL NON-MOTORIZED TRAILS IN THE DISTRICT DURING THE TRAIL BUILDING SEASON OF OCTOBER TO MARCH 2019. THE FUNDE PROVIDED IN SEPTEMBER 2019 (FY19) WILL ALLOW THE FOREST SERVICE DISTRICT TO HIRE A TEN PERSON CREW FOR THE COMING TRAIL BUILDING AND MAINTNENANCE SEASON. THE DISTRICT PLANS TO WORK ON 300 MILES OF TRAILS THIS NEXT SEASON.

THE AREA ON THE WESTERN EDGE OF THE CITY OF SEDONA HAS BEEN DESIGNATED AS THE WESTERN GATEWAY WITH MOST OF THIS AREA BEING NATIONAL FOREST LAND. THIS AREA ALREADY CONTAINED SOME MILES OF OFFICAL FOREST SERVICE TRAILS AND MANY USER CREATED, SOCIAL TRAILS. THESE TRAILS IN SOME PLACES INFRINGED ON PRIVATE LAND, INVADED ARCHEOLOGIC SITES AND WERE SUBJECT TO EROSION INTO THE OAK CREEK WATERSHED. IN 2018 THE DISTRICT RANGER SIGNED THE RED ROCK TRAILS ENHANCEMENT DECISION MEMO AUTHORIZING A SYSTEM OF TRAILS IN THIS AREA IMPROVING AND ADOPTING 11 MILES OF USER-CREATED ROUTES COMBINED WITH 15 MILES OF NEW TRAILS AND RE-ROUTING 2.8 MILES TO CREATE A ~29 MILE MULTI-USE TRAIL SYSTEM.
